JOB TITLE: PROJECT FINANCE & ACCOUNTS OFFICER

Overall Objective of Position

Caritas Ghana initiated its Social Impact Investment - SII initiative, which follows the call of Pope Francis' "Care for our common home" from his Laudato Si to protect the environment and help the vulnerable and poor. The initiative is active in the field of circular economy/waste management. Different types of waste are collected, processed

and fed into formal recycling structures.

The Social Impact Investment (SII) Model of Caritas Ghana is a sustainable and non-profit oriented waste campaign. Incorporated in the communitarian context of the Catholic Church, which means Caritas Ghana is close to the community. In this way, Caritas Ghana can raise awareness and also support the authorities in circular

economy.

Duration: The position is available on an nine-month contract from 1st April, 2022 to 31st of December, 2022 with good prospects of extension into a permanent contract.

Duties/Responsibilities

The duties/responsibilities will include but not limited to the following:

- 1. Support the Team and sub-teams in all matters of financing and accounting.
- 2. Ensure that funds are spent and managed according to the goals, objectives and missions of the Donor and Caritas Ghana.
- 3. Ensure that ongoing operational activities follow business management rules.
- 4. Establishes robust tools that ensure efficient controlling during project phases/implementation and operations.
- 5. Support and monitor the sourcing processes to ensure that they are in line with Caritas Ghana, the National Catholic Secretariat (NCS) and Donor's requirements.
- 6. Ensure that funds are being used according to budgeted plan and that the allocation of expenditures is appropriate to the function identified for the account.
- 7. Prepare budget cash flow and cash book analysis.
- 8. Prepare financial statements to the involved parties both locally and internationally.

Educational, Professional Qualification and Experience for Appointment:

- Bachelor's Degree in Economics, Commerce (Accounting/Finance), Business Administration (Accounting/Finance) or any other recognized equivalent qualification from a recognized Institution.
